

## **RFP-Expressing Human Primary Small Intestinal Tumor-Associated Epithelial Cells**

### **Product Description**

RFP-Expressing Human Primary Small Intestinal Tumor-Associated Epithelial Cells from Cell Biologics are isolated from human small intestinal tumor tissue and grown in gelatin pre-coated tissue culture flasks with Cell Biologics' Complete Growth Medium. Cells at passage 3 are harvested from flasks and cryo-preserved in vials. Each vial contains  $0.5 \times 10^6$  cells per ml and is delivered frozen. Cells are characterized by immunofluorescent staining with E-cadherin (Catalog No. 610182 from BD) or ZO-1 (Catalog No. 617300; from Life Technologies) antibody. These cells are negative for mycoplasma, bacteria, yeast, fungi, HIV-1, hepatitis B and hepatitis C and can be expanded for 3-5 passages at a split ratio of 1:2 under the cell culture conditions specified by Cell Biologics. Repeated freezing and thawing of cells are not recommended.

Red Fluorescent Protein (RFP), a mutant form of green fluorescent protein, gives rise to very bright red fluorescence when exposed to yellow-green light. Cell Biologics generates various RFP-Expressing stable cells, including endothelial cells, Tumor-Associated Epithelial Cells and so forth. RFP-Expressing cells are developed through transducing RFP-lentiviral particles.

### **Storage**

Cryopreserved cells are shipped with dry ice overnight. Upon arrival, transfer frozen cells to liquid nitrogen ( $-180^{\circ}\text{C}$ ) immediately until ready for use. Live cell shipment is also available on request. Primary cells can never be kept at  $-20^{\circ}\text{C}$  or  $-80^{\circ}\text{C}$  freezer.
