

## **GFP-Expressing Human Primary Diabetic Gingival Epithelial Cells**

### **Product Description**

GFP-Expressing Human Primary Diabetic Gingival Epithelial Cells from Cell Biologics are isolated from gingival tissue of human donors that have been diagnosed with diabetes type II disease. Cells are grown in gelatin pre-coated tissue culture flasks with Cell Biologics' Complete Growth Medium. Cells at passage 3 are harvested from flasks and cryo-preserved in vials. Each vial contains  $0.5 \times 10^6$  cells per ml and is delivered frozen. Cells are characterized by immunofluorescent staining with E-cadherin (Catalog No. 610182 from BD) or ZO-1 (Catalog No. 617300; from Life Technologies) antibody. These cells are negative for mycoplasma, bacteria, yeast, fungi, HIV-1, hepatitis B and hepatitis C and can be expanded for 3-5 passages at a split ratio of 1:2 under the cell culture conditions specified by Cell Biologics. Repeated freezing and thawing of cells are not recommended.

The green fluorescent protein (GFP) gives rise to very bright green fluorescence when exposed to blue light. Cell Biologics generates various GFP-Expressing stable cells, including endothelial cells, epithelial cells and so forth. GFP-Expressing cells were developed through transducing GFP-lentiviral particles.

### **Storage**

Cryopreserved cells are shipped with dry ice overnight. Upon arrival, transfer frozen cells to liquid nitrogen ( $-180^{\circ}\text{C}$ ) immediately until ready for use. Live cell shipment is also available on request. Primary Diabetic cells can never be kept at  $-20^{\circ}\text{C}$  or  $-80^{\circ}\text{C}$  freezer.
