Product Description

Cas9-Expressing Cynomolgus Monkey Primary Lymphatic Fibroblasts from Cell Biologics are isolated from cynomolgus monkey lymph nodes of Monkey and grown in gelatin pre-coated tissue culture flasks with Cell Biologics' Complete Growth Medium. Cells at passage 2-3 are harvested from flasks and cryo-preserved in vials. Each vial contains 0.5×10^6 cells per ml and is delivered frozen. Cas9-Expressing Cynomolgus Monkey Primary Lymphatic Fibroblasts are characterized by their spindle morphology and immunofluorescence staining with anti-fibronectin antibodies. These cells are negative for bacteria, yeast, fungi, mycoplasma, HIV-1, hepatitis B and hepatitis C. Cells can be expanded for 3-5 passages at a split ratio of 1:2 under the cell culture conditions specified by Cell Biologics. Repeated freezing and thawing of cells are not recommended.

Cell Biologics generates Cas9-expressing stable cells through transducing Cas9-lentiviral particles. Cas9-stable cells express wild-type Cas endonuclease.

Storage

Cryopreserved cells are shipped with dry ice overnight. Upon arrival, transfer frozen cells to liquid nitrogen (-180°C) immediately until ready for use. Live cell shipment is also available on request. Primary cells can never be kept at -20°C or -80°C freezer.
