

## **BKS db Control Mouse Cardiac Fibroblasts**

### **Product Description**

BKS db Control Mouse Cardiac Fibroblasts are isolated from the heart of C57BLKS/J (00662) pathogen-free laboratory mice and grown in gelatin pre-coated tissue culture flasks with Cell Biologics' Complete Growth Medium. Cells at passage 2-3 are harvested from flasks and cryo-preserved in vials. Each vial contains  $0.5 \times 10^6$  cells per ml and is delivered frozen. BKS db Control Mouse Cardiac Fibroblasts are characterized by their spindle morphology and immunofluorescence staining with anti-FSP1/S100A4 (Millipore USA) antibodies. These cells are negative for bacteria, yeast, fungi, and mycoplasma. Cells can be expanded for 3-5 passages at a split ratio of 1:2 under the cell culture conditions specified by Cell Biologics. Repeated freezing and thawing of cells are not recommended.

### **Laboratory Applications**

BKS db Control Mouse Lung Fibroblasts can be used for the assay of cell-cell interaction, adhesion, PCR, Western blot, immunoprecipitation, immunofluorescent flow cytometry, or generating cell derivatives for desired research applications.

### **Storage**

Cryopreserved cells are shipped with dry ice overnight. Upon arrival, transfer frozen cells to liquid nitrogen ( $-180^{\circ}\text{C}$ ) immediately until ready for use. Live cell shipment is also available on request. Primary cells can never be kept at  $-20^{\circ}\text{C}$  or  $-80^{\circ}\text{C}$  freezer.
