

## Immortalized GFP-Expressing Rabbit Primary Skeletal Muscle Cells

### Product Description

Immortalized GFP-Expressing Rabbit Primary Skeletal Muscle Cells from Cell Biologics are isolated from the skeletal muscle tissue of New Zealand white rabbits and grown in gelatin pre-coated tissue culture flasks with Cell Biologics' Complete Growth Medium. Cells at passage 2-3 are harvested from flasks and cryo-preserved in vials. Each vial contains  $0.5 \times 10^6$  cells per ml and is delivered frozen. Immortalized GFP-Expressing Rabbit Primary Skeletal Muscle Cells are characterized by immunofluorescence staining with  $\alpha$ -smooth muscle actin antibody and negative for bacteria, yeast, fungi, and mycoplasma. These cells can be expanded for more than 10 passages at a split ratio of 1:2 under the cell culture conditions specified by Cell Biologics. Repeated freezing and thawing of cells are not recommended.

Immortalized cells from Cell Biologics are derived from primary cells expressing GFP. These primary cells are immortalized by over-expression of the large T-antigen of the simian virus (SV40) or human telomerase reverse transcriptase (hTERT).

The green fluorescent protein (GFP) gives rise to very bright green fluorescence when exposed to blue light. Cell Biologics generates various GFP-expressing stable cells. GFP-expressing cells are developed through transducing GFP-lentiviral particles.

### Storage

Cryopreserved cells are shipped with dry ice overnight. Upon arrival, transfer frozen cells to liquid nitrogen ( $-180^{\circ}\text{C}$ ) immediately until ready for use. Live cell shipment is also available on request. Primary cells can never be kept at  $-20^{\circ}\text{C}$  or  $-80^{\circ}\text{C}$  freezer.
